2023 SOCCER TOURNAMENT GIVEAWAY OFFICIAL RULES

**NO PURCHASE IS NECESSARY TO ENTER OR WIN.  
A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.**

- 1. Eligibility:** Giveaway (the "Giveaway") is open to those who complete a Giveaway entry form and meet the criteria set forth herein during the Giveaway Period (defined below). The Giveaway is only open to adults 21 years of age or older who are legal US residents and have a valid U.S. Class A Commercial Driver's License in their name as of the Giveaway date. Employees of the International Trucking Association (the "Sponsor") its respective sponsors, affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Giveaway. The Giveaway is subject to all applicable federal, state and local laws and regulations and is void where prohibited by law.

THE MACHINERY (INCLUDING ANY ACCESSORIES AND COMPONENTS) IS GIVEN AWAY "AS IS."** The specifics of the prize shall be solely determined by the Sponsor. 10. **Terms:** The ITA reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Giveaway should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Giveaway. In such case, the ITA may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by the ITA. The ITA reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Giveaway or website or violates these Terms & Conditions.
